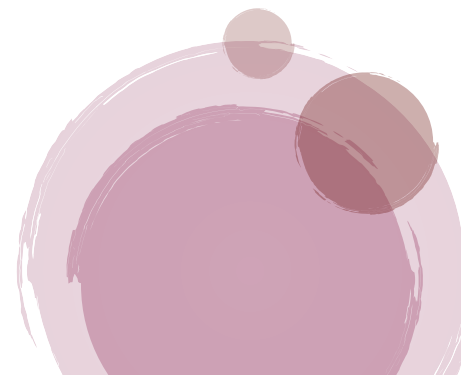


## CGMA® LEADERSHIP ACADEMY
